- Employees: 个 physical activity and job satisfaction
- Environment: ↓ vehicle usage, ↓GHG
- Business: ↓ \$\$\$ for cabs, gas, vehicle fleets,
   ↓health insurance costs

- 6 Bikes + Rack : Purchased by 12/31/2013
  - 4 more added including a tricycle with basket
- Delivery helped expedite legal + facilities

   sense of urgency & inevitability
- Procedures + Protocols designed
- Multiple approvals

- Individual Liability + Program Policy Waivers
- SharePoint reservation system (automated)
- Program + bike safety orientation held regularly
- Volunteer bike maintenance
  crew
  - Launch party/ribbon cutting





- Safety and logistical education (LAB-based) in-person, video, or PowerPoint
- Employee BikeShare Program Toolkit for Government Agencies for new and potential implementers

• Staffing of a BikeShare (Program Manager, Communications, Maintenance/Facilities)



- Trip types: Errands, physical activity, business trips
- Times of day: peak/off-peak
- Maintenance: on-site staff, volunteers, or contracted through local bike shop
- BIG meeting: knowledge transfer (promotional ideas, problem-solving, etc.) and support



## **System Status**

- 4.5 years of existence
- Nearly 5,000 trips
- **400+** Registered Users
- 50+ Trainings
- **0** Reported Injuries
- 1 in-service flat tires
- **0** thefts
- Immeasurable increase in demand for MORE (of everything)
- 2 bikes added





## System Status (Cont'd)

- Expansion years: 2015, 2016, 2017, 2018
- As of 2018, 14 state agencies involved
- >16,000 employees with access in NorCal
- ~120 bikes in service

## System feedback

## **Lessons Learned**

- *BikeShare* is a viable strategy for creating physical activity opportunities for employees.
- A low-barrier system that is convenient will pique employee interest and participation.
- Public-private partnerships may be ideal (or essential) for some government entities to fund and launch similar programs.



## **Takeaway Messages**

- Create opportunities
- Play offense: Find the right champions
- Play defense: Strategize and prepare for cynics
- Accept bureaucracy mentally and in your timelines
- Demonstrate values and wins every chance
- Commitment is key... communication is more key
